Pulmonary arterial hypertension designated treatment centre criteria

Pulmonary Arterial Hypertension treatment centres satisfy the following criteria:

- facility which has access to PAH services such as:
 - Heart lung transplant unit
 - PAH management services/clinic
 - Scleroderma management services/clinic
 - State/Territory health recognised cardiovascular centre.
- > experience and expertise in managing patients with PAH:
 - Current PAH management protocol
 - o Experience in prescribing PAH therapies.
- > the availability of diagnostic services and expertise with procedures such as right heart catheterisation (RHC), echocardiography (Echo), pulmonary function testing (PFT) and six minute walk test protocol (6MWT).
- > outpatient pharmacy services and pharmacy expertise in managing Section 100 listed drugs and other highly specialised therapy.

Each potential designated centre is rated as to their ability to satisfy the above criteria on a scale of 0, 1 or 2. A minimum rating of six out of eight could result in a hospital becoming a designated treatment centre.

The rating definitions are as follows for the above criteria:
