	MFA	Multi-Factor Authentication – additional security measure to protect patient data against unauthorised access.
	NALHN	Northern Adelaide Local Health Network
	NDE	National Data Exchange – captures and stores monitored drug information from state and territory regulatory systems, and prescribing and dispensing software.
	NPCP	Notified Palliative Care Patient – patient who has been notified to the Drugs of Dependence Unit as having a life expectancy of less than 12 months.
	PES	Prescription Exchange Service (i.e. <u>eRx</u> , <u>MediSecure</u> ) – provides secure and safe electronic transfer of prescription information between prescribers and pharmacists. It enables the delivery of monitored drug information to <b>Script</b> Check <b>SA</b> in real-time.
	PBS	Pharmaceutical Benefits Scheme
	PHN	Primary Health Network
	RTPM	Real-Time Prescription Monitoring – computer software that provides prescribers and pharmacists with information about a patient's use of monitored drugs when they are considering prescribing or dispensing these medicines. Eg. <b>Script</b> Check <b>SA</b> , SafeScript, SafeScript NSW, QScript, NTScript.
	S4	Schedule 4 of the Standard for the Uniform Scheduling of Medicines and Poisons – Prescription Only Medicine
	S8	Schedule 8 of the Standard for the Uniform Scheduling of Medicines and Poisons – Controlled Drug / Drug of Dependence
	S18A	Section 18A of the <i>Controlled Substances Act 1984</i> - defines the authority requirements for prescribing drugs of dependence (Schedule 8 drugs).
