

# Clinical Services Plan Community Consultation

5 February 2025

The Limestone Coast Local Health Network (LCLHN) is commencing planning for the future of health services across our region with the development of a Clinical Services Plan (the CSP). In line with the [LCLHN Strategic Plan 2021-2025](#) and our **core purpose**, we will partner with our community throughout this process, to support us in delivering best practice care and services that contribute to improving the health and wellbeing of our communities and region.

Aligned to our **Strategic Priority 1: Growing Services** by planning, developing and implementing a regionally-connected hub and spoke model for service delivery, the CSP will provide a 10 year roadmap to support the LCLHN to better meet the health needs of all Limestone Coast communities.

The CSP will consider our obligations in relation to the delivery of public health services, opportunities for how we can make the most effective use of available resources across our sites and services, and what we can achieve to improve health service delivery, population outcomes and system performance.

The CSP will act as the key plan for what, where and how we deliver hospital and community services across the region in the coming years. Providing clear direction and recommendations in relation to clinical services and infrastructure that will inform our operational planning processes and guide future investment.

In line with our [Engagement Strategies](#), we will **involve** our clinicians, staff and volunteers, our consumers, carers and communities, and our service partners and external stakeholders throughout the process. Providing an opportunity for their views and insights to **inform** and **influence** the development of the CSP.

Consulting firm Destravis Group have been appointed to lead the planning process and have already commenced preparations for a range of consultation sessions to be held in the first half of this year. Feedback received throughout this process will inform a draft plan that is scheduled to be available for consideration and feedback by June 2025.

Broad consultation will commence in the week beginning 24 February 2025, and will provide an opportunity for you to actively participate and have your say. There will be face-to-face meetings held in Bordertown, Keith, Kingston SE, Lucindale, Mount Gambier, Millicent, Naracoorte and Penola, and an online survey that you can undertake at your convenience.

We look forward to working with you as we develop the Clinical Services Plan for our Network.
