#### Your wishes for future care.

There may come a time when you are unable to make a decision or properly communicate your wishes on how you'd like to be cared for or treated.

It could be for a number of reasons including:

- an accident or mental health episode
- dementia or similar condition
- a sudden serious stroke or
- because you are unconscious or in a coma.

This can happen at any age or stage of life. If it did, how would you want decisions to be made for you about your ongoing health care, living arrangements and other personal matters? **And, who would you want to make those decisions for you?** 

To make an Advance Care Directive, it must be your choice and you must:

- Be aged 18 years and older
- Have decision-making capacity
- Know what an Advance Care Directive is
- Know what it will be used for and when it will be used.

## What is an Advance Care Directive?

An Advance Care Directive is a legal form that allows you to provide direction about your care in advance.


# What will it allow me to do?

It can record your wishes for your future care, including health care, end of life, preferred living arrangements and other personal matters.

It can also be used to appoint one or more adults (known as Substitute Decision-Makers) to make these decisions for you, if you are unable to make particular decisions.

### Why should I have one?

It can give you peace of mind knowing that those who care for you will know what you want when you are no longer able to make particular decisions or communicate your wishes and preferences. It can also help avoid family conflict in stressful situations.
