The mandatory training package for medical practitioners has also been approved and is now available for interested medical practitioners. If you are a Medical Practitioner, you are welcome to visit the <u>Voluntary Assisted Dying Clinical Portal</u> to register and sign up for access to the mandatory training.

Pharmacy Service, Operations and Review Board Secretariat staff have commenced work, with their Care Navigator and LHN liaison colleagues expected to join them soon. It's been great to see such experienced and committed team members come onboard to support the Voluntary Assisted Dying Pathway as it approaches reality.

Spotlight on...the Voluntary Assisted Dying Clinical Portal


Navigating any new process is challenging, but the Voluntary Assisted Dying Clinical Portal will help medical practitioners quickly and securely access their mandatory training and complete all the necessary paperwork for patients on the Voluntary Assisted Dying Pathway.

The Clinical Portal is the secure online system used by medical practitioners to manage requests for voluntary assisted dying in South Australia.

Only authorised medical practitioners and SA Health employees supporting voluntary assisted dying processes can access the Clinical Portal.

Medical practitioners will be able to use the Clinical Portal to:

- access the Voluntary Assisted Dying Mandatory Medical Practitioner Training
- complete and submit forms required to access voluntary assisted dying
- apply for a permit to prescribe a voluntary assisted dying medication.



The Clinical Portal has been adapted from the system already used in Western Australia to fit the needs of the South Australian legislation.

Comprehensive testing has been completed to ensure the product passes privacy and security requirements, as well as ensuring that it meets the needs of the medical practitioners who will be using it.

Medical practitioners can now register to complete the mandatory training via the Clinical Portal by heading to www.sahealth.sa.gov.au/vad and following the links.



Did you know?

Mandatory training for medical practitioners who participate in voluntary assisted dying is a critical safeguard embedded within the <u>Voluntary Assisted Dying Act 2021</u> (the Act).

A team from Flinders University and the Digital Learning & Design unit within the Women's and Children's Health Network led the development of the mandatory voluntary assisted dying training package which medical practitioners will be required to successfully complete to participate as a Coordinating or Consulting Medical Practitioner under the Act.

Two face-to-face training sessions have also been scheduled for early December 2022 for eligible medical practitioners to attend to complete the mandatory training.

<u>Eligible medical practitioners</u> can now register to access the voluntary assisted dying medical practitioner training at www.sahealth.sa.gov.au/vad.

SA Voluntary Assisted Dying Implementation Conference

The SA Voluntary Assisted Dying Implementation Conference was held virtually on Wednesday 16th November 2022. The conference provided information about how voluntary assisted dying will be implemented in South Australia including an overview of the process and support services.

Starting with the Voluntary Assisted Dying Implementation Team in January 2022, Lauren has led the development of the pharmacy service model and medication protocols, as well as contributing to broader aspects of implementation such as the clinical guidelines and clinical portal.
