From the Presiding Members

The Mount Gambier and Districts Health Advisory Council (HAC) is proud to be a part of the annual report and demonstrate its ongoing commitment to the enhancement of the health and wellbeing of the local community.

Communication and engagement with the local community has been a focus on the HAC over the 2018-19 year. This work has included the use of both printed and social media platforms with the first HAC newsletter collated and circulated as well as the use of the HAC Facebook page to promote HAC activities of interest to the community. In response to community requests the HAC organised a Palliative/End of Life Care Forum with an estimated 160-170 in attendance in the Town Hall. The forum generated much discussion on the night and ongoing focused work in this important area to ensure the community is well informed of services available to them. As a group we continue to explore opportunities to improve our services including the reintroduction of Palliative Care volunteers locally.

Over the past year the focus on key fundraising has continued, with a view to support the current project for Paediatric/Maternity upgrade. In August 2018 the Super Hero Ball August raised \$13,800 with the Super Hero Campaign now achieving a total amount of \$36,000. The support of the community continues to be both encouraging and humbling, with the HAC very grateful for the ongoing support for our health service.

In a similar vein the HAC has actively sought an opportunity to obtain external funds to enhance our services. In December 2018 the HAC initiated a successful grant application to SA Variety, receiving approval of \$77,000 towards clinical equipment that will enhance efficient diagnosis and treatment of babies and children for the Paediatric area. This grant will also see the commencement of work to upgrade of the outdoor play area adjacent the Paediatric ward.

Over the last twelve (12) months the HAC has approved \$23,000 expenditure towards equipment including an \$11,000 contribution towards the purchase of the Argon Diathermy machine for the theatre unit. Three local Rotary clubs combined with the Rotary foundation contributed a further \$18,000. The community should be reassured that any donations received by the HAC are managed in a collaborative and considered manner, with the community assured that all funds received will support care provided locally.

Additional activities of the HAC include the establishment of a Garden Committee to enhance Hospital grounds, providing feedback in response the Rural Health Workforce Strategy in particular the Recruitment and Retention of Doctors in Rural Australia, as well as responding to Community issues and concerns. Issues raised have included Car parking on site, the desire for increased promotion of health topics in particular health prevention measures and advocating for new migrants in our community.

It is of note that the MG&DHAC were nominated for a Country Health SA Local Health Network (CHSALHN) Award during this year.

On behalf of the HAC I would like to thank the community for their interest, feedback and support. We continue to be focused on achieving the best care for our community and advocating for wellness and health care needs.

INDEPENDENT AUDITOR'S REPORT

TO THE MEMBERS OF THE MOUNT GAMBIER AND DISTRICTS HEALTH ADVISORY COUNCIL INC. GIFT FUND TRUST

Report on the Financial Report

We have audited the accompanying financial report of Mount Gambier and Districts Health Advisory Council Inc. Gift Fund Trust (the Gift Fund Trust), which comprises the statement of financial position as at 30 June 2019, the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, notes comprising summary of significant accounting policies and other explanatory information, and the statement by the presiding member and operational finance manager.

In our opinion, the financial report of Mount Gambier and Districts Health Advisory Council Inc. 



1 Basis of financial statements

1.1 Reporting entity

The Mount Gambier and Districts Health Advisory Council Inc Gift Fund Trust (the Trust) was established by virtue of a deed executed between the Department for Health and Wellbeing and the Mount Gambier and Districts Health Advisory Council Inc (the Trustee).

The financial statements include all controlled activities of the Trust.

The Trust does not control any other entity and has no interests in unconsolidated structured entities.

1.2 Statement of compliance

These financial statements are general purpose financial statements prepared in compliance with:

- section 23 of the *Public Finance and Audit Act 1987*;
- Treasurer's Instructions and Accounting Policy Statements issued by the Treasurer under the Public Finance and Audit Act 1987; and
- relevant Australian Accounting Standards (with reduced disclosure requirements) applicable to not-for-profit entities, as the Trust is a not-for-profit entity.

1.3 Basis of preparation

The financial statements have been prepared based on a 12 month period and presented in Australian currency. All amounts in the financial statements and accompanying notes have been rounded to the nearest thousand dollars (\$'000).

The historical cost convention is used unless a different measurement basis is specifically disclosed in the note associated with the item measured on a different basis.

Assets and liabilities that are to be sold, consumed or realised as part of the normal operating cycle have been classified as current assets or current liabilities. All other assets and liabilities are classified as non-current.

Significant accounting policies are set out below or in the notes.

1.4 Taxation

The Trust is not subject to income tax but is liable for goods and services tax (GST).

Income, expenses and assets are recognised net of the amount of GST except:

- when the GST incurred on a purchase of goods or services is not recoverable from the Australian Taxation Office (ATO), in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item applicable; and
- receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis, and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the ATO is classified as part of operating cash flows.

1.5 Change in accounting policy

On 22 March 2019, pursuant to the *Public Finance and Audit Act 1987*, the Treasurer issued *Treasurer's Instructions (Accounting Policy Statements)* and revoked all previously issued Accounting Policy Statements. The new Accounting Policy Statements have largely been prepared on a no-policy change basis.

AASB 9 Financial Instruments

The adoption of AASB 9 from 1 July 2018 resulted in changes in accounting policies but no adjustments to the amounts recognised in the financial statements.

AASB 9 replaces the provisions of AASB 139 Financial Instruments: Recognition and Measurement that relate to recognition, classification, impairment and measurement of the Trust's financial assets.

Under AASB 9, the Trust's receivables and term deposits are measured at amortised cost, similar to the previous classifications of 'receivables' and 'held to maturity' respectively.




