Southern Adelaide Local Health Network (SALHN) Freedom of Information – Information Statement

The following information is published pursuant to Section 9 of the *Freedom of Information Act 1991* (the Act).

Freedom of Information (FOI)

The objects of the Act are:

- To promote openness in government and accountability of Ministers of the Crown and other government agencies and thereby to enhance respect for the law and further the good government of the State;
- To facilitate more effective participating by members of the public in the processes involved in the making and administration of laws and policies;
- To ensure that records held by government concerning the personal affairs of members of the public are not incomplete, incorrect, out of date or misleading.

The Act encourages disclosure of information to the public, subject to such restrictions within the Act as are necessary to protect legitimate agency, public and private interests.

Making a Freedom of Information application

Application forms to request information under the FOI Act or to request amendment of personal records can be obtained by contacting the SALHN FOI Service (contact details below), visiting the SALHN website, downloading an application form from the State Records website or lodging an online application.

An application for access lodged under the FOI Act costs \$38.25 payable to the agency, and additional processing charges may also be incurred.

In certain cases, a reduction of fees and charges may apply.

An application for amendment of personal records is free of charge.

Agency's functions and structure as at 30 June 2021

SALHN provides public health services including hospital, outpatient and community services to a population of more than 355,000 people across the Southern Adelaide metropolitan region and the Fleurieu Peninsula, as well as a range of state-wide and regional services.

SALHN is unique in the state public health system as it provides services across the lifespan, from obstetrics, maternity and neonatal services, to end of life care provided through hospital and community based palliative services. Services are provided from Flinders Medical Centre (FMC); Noarlunga Hospital; GP Plus Super Clinic Noarlunga, GP Plus centres at Marion and

Aldinga; the Jamie Larcombe Centre at Glenside; 'the Repat' precinct, as well as direct care and support in patients' homes.

Public Participation

Consumers provide advice and feedback to SALHN to ensure greater transparency in decision-making, and to ensure greater accountability to the community. The SALHN Community Engagement Board Sub-Committee exists to ensure a strategic, effective and coordinated organisational approach is undertaken to community engagement, participation and partnerships to improve the health and wellbeing of the population.

SALHN's Partnering with Consumers Advisory Group (PWCAG) is a 'Lead committee' established to ensure there are clear and diverse consumer and community voices integrated into all services. It also advises Executive and ensures there are systems in place to assist SALHN to achieve our operating principle: "To Listen, Act, Make Better, Together".

SALHN co-designs its health service with consumers throughout all stages and processes of planning, design, delivery, measurement and evaluation of care, from an individual to a state wide level.

Community feedback is sought to deliver effective review and evaluation of health services and improvement of patient experience and health outcomes.

Governance of the Agency

The SALHN Governing Board is the peak governing body of SALHN with oversight responsibilities for SALHN's strategy, risk, compliance and performance. The Board meets on a monthly basis and utilises Clinical Governance; Community Engagement; Audit and Risk, and Capital Projects Sub-Committees to ensure it delivers on its obligations as stated in the *Health Care Act 2008 (SA)* and *Health Care (Governance Reform) Act 2018 (SA)*. SALHN's Executive Committee is the most senior operational decision-making body. It meets on a number of occasions per month to monitor and review SALHN's performance in relation to our five management domains of safety, quality, delivery, people and cost.
