### Freedom of Information - Information Statement

Information must be made available to people who have a right to it.

This information statement is published in accordance with Section 9 of the Freedom of Information Act 1991 SA (the Act).

An "Act' is the term used to identify decisions made in the parliament which have been agreed, documented and passed into law.

# Freedom of Information (FOI)

The aims of the Act are to achieve respect for the law, and further the good government of the state:

For that reason the Act requires

- openness in government
- accountability of Ministers of the Crown and all government departments and agencies
- participation by members of the public in the processes which make and apply laws and policies:
- Accuracy, completeness, clear and up to date general information and personal information held in government record systems
- Restriction of access to information only as necessary to protect rightful interests of government the public and private interests.

# Making a Freedom of Information application

Applications can be made for information from government records about

- individual personal information
- requests for changes to records of personal information
- information of interest to the general public.

Application forms can be obtained by

- contacting the relevant CALHN FOI services (listed below)
- visiting the CALHN or State Record websites, and downloading an application form
- lodging an online application.

An application fee is required to be paid and there may be additional processing charges.

In certain cases, a reduction of fees and charges may apply.

An application for amendment (correction) of personal records is free of charge.

CALHN uses SA Health policy documents

These are defined as:

- Data and information
- Financial management

- · Procurement and asset management.

The following documents are held by CALHN:

- · Hospital By-Laws
- Patient Medical Records and Medical Imaging
- Corporate files containing correspondence, memoranda, minutes, etc., regarding all aspects of agency operations.
- · Personnel files relating to CALHN employees
- · Accounting and financial records relating to the administration of the agency
- Contracts.

#### **CALHN's functions and structure**

CALHN's purpose is to provide all South Australians with the right healthcare at the right time at the right place.

CALHN is committed to:

providing high quality health and clinical care

participating in education training and research.

CALHN is a government agency with a number of divisions called 'programs or clinical services' which are explained in the Annual Report under the 'Reporting Structure'.

#### **Governance of CALHN**

The word 'governance' refers to how individuals and groups in society use power, authority and influence to make policies and decisions.

The State Government has established SA Health's governance arrangements by forming Local Health Network (LHN) Governing Boards, which became fully operational on 1 July 2019.
