The membership includes Reservists from Navy, Army and Air Force as well as exserving veterans and medical specialists who deal with veterans.

I take this opportunity to thank members sincerely for giving of their time so freely and for the contribution they make both individually and collectively to help improve the health and wellbeing of veterans and their families.

I am concerned that VHAC has been unable to achieve gender equity or first nation representation in its membership and will work to address this matter throughout the coming year.

A priority for VHAC throughout 2021-22 has been our collaboration with SA Health in developing a 2022-25 Veteran Wellbeing Action Plan. This plan, when complete, will build on the work contained in the earlier Frameworks for Veterans' Health Care. A key objective identified within these plans, which has yet to be achieved, is the ability to identify and record a veteran's status at point of entry to the State's public health system. VHAC will continue to advocate for this to be achieved.

VHAC is maintaining a watching brief on the findings and recommendations of the Royal Commission into Defence and Veteran Suicide and will provide advice to our Minister as appropriate.

Members of VHAC were involved with the steering group to establish the Veterans' Wellbeing Centre at the Repat in Daw Park. VHAC remains committed to the successful development of the initial vision for the facility.
