

### 2. Vote Methodology

Eligible employees were notified of the time and date of the SA Health Clinical Academics Enterprise Agreement 2024 vote in a CiVS letter.

Voting channels (online and SMS), voting information, username and PIN information were distributed to voters from CiVS by email. This email included information on how to vote and confirmation of the vote opening date and time. See *Appendix A: Email Notification* for full email content.

A SMS was sent to eligible employees with username and PIN, vote URL and confirmation of the vote opening date and time. See *Appendix B: SMS Notification* for the full SMS content.

A SMS was sent to eligible employees when the vote opened requesting the voter reply yes or no. See *Appendix C: SMS Question* for the full SMS content.

### 3. CiVS Independence Declaration

No individual vote has been disclosed to SA Health.

Important: please ensure your employer has your current mobile phone number.


Only votes lodged within the above voting period can be counted. You can only vote once and after you have submitted a vote it cannot be changed.


