1. Name of Policy

Health Technology Assessment

2. Policy statement

This Policy sets out the mandatory requirements that apply across SA Health in relation to Health Technology Assessment (HTA) and the requirement to refer all high-risk and/or high-cost health technologies, as well as those with statewide implications, to the South Australian Policy Advisory Committee on Technology (SAPACT), to enable quality healthcare through the use of innovative health technologies in South Australia that are safe, clinically-effective and/or cost-efficient.

3. Applicability

This policy applies to all employees and contracted staff of SA Health; that is all employees and contracted staff of the Department for Health and Wellbeing (DHW), Local Health Networks (LHNs) including state-wide services aligned with those Networks and SA Ambulance Service (SAAS).

This policy applies in relation to new and emerging health technologies registered on the Therapeutic Goods Administration Australian Register of Therapeutic Goods (TGA ARTG), comprising of diagnostic and treatment interventions such as diagnostic tests, prostheses, implantable devices, and medical and surgical procedures.

Out of scope

Out of scope health technologies include those undergoing clinical, research or ethical trials, as well as those already assessed through other pathways within SA Health such as high-cost medicines, highly specialised therapies, biomedical engineering, pathology, radiology, and blood and tissue products. High-volume, low-cost health technologies are exempt from SAPACT assessment and are currently encompassed in other procurement and assessment processes.

4. Policy principles

SA Health's approach to HTA is underpinned by the following principles:

- > We will support for clinical innovations and health technologies that are proven to be safe, clinically effective and/or cost-effective, to improve patient and health system outcomes.
- > We will maintain a statewide HTA governance framework and associated processes for transparent, timely and effective health technologies evaluation.
- > We will incorporate internationally recognised HTA principles, methodologies and methods to inform evidence-based decision-making.
- > We will promote equity of access to health technologies for all South Australians living in both metropolitan and regional areas.
- > We will support processes to monitor and evaluate patient and clinical outcomes from the implementation of a health technology.
- > We will encourage the building of HTA capacity in SA Health.

5. Policy requirements

Statewide HTA Governance Framework

The SA Health DHW HTA Program must maintain a statewide HTA governance framework to manage and assess the entry of new and emerging health technologies. The HTA framework incorporates delegation of HTA decision-making to the appropriate statewide level and LHN level.

- > **Statewide level:** New and emerging health technologies meeting the SAPACT criteria of high-risk, high-cost or those with statewide service planning implications, must be referred for evaluation to SAPACT and obtain a positive or conditional SAPACT Advisory Recommendation, prior to purchase and implementation in SA Health.
- > **LHN level:** New and emerging health technologies outside the scope of SAPACT must be subjected to review by the relevant LHN New Technology Committee(s) or a LHN delegate (e.g. LHN Representative(s) to SAPACT), prior to purchase and implementation in the relevant LHNs:
 - CALHN New Clinical Procedures, Services or Other Interventions Committee
 - SALHN New Health Technology & Clinical Practice Innovation Committee
 - NALHN Procedures and Services Committee
 - WCHN New Health Technologies and Interventions Committee
 - Regional LHNs: LHN regional representatives to SAPACT or as delegated.
- > The introduction of new and emerging health technologies must also include considerations on the disinvestment of old or obsolete health technologies, to accommodate evolving clinical practice and health service provision.

Statewide HTA review process

- > DHW, LHNs, SAAS and statewide clinical networks must comply with [Appendix 1. HTA Process Flowchart for the Assessment of New Technologies in SA Health Mandatory Instruction](#).
- > SA Health clinicians and/or clinical groups seeking to use a new health technology must submit the [SAPACT Application Form for New Health Technology](#) to SAPACT, through the relevant LHN New Technology Committee or LHN Representative.
- > When the HTA review is completed, the SAPACT Advisory Recommendation must be communicated to the chief applicant of the new health technology and associated Chair(s) of the LHN Health Technology Committee(s).

Engagement and implementation

- > LHNs must assist SAPACT in engaging with their LHN clinicians for HTA evaluation and communicate SAPACT Advisory Recommendations and other relevant statewide HTA activities to appropriate LHN stakeholders.
- > LHNs must abide by the requirements and implementation of the SAPACT Advisory Recommendations and/or SAPACT HTA Decision Summaries, in line with the LHN's local organisational feasibility, credentialing, scope of practice, competency and financial considerations.

Funding

- > Funding decisions of health technology must be managed locally by the LHNs or health services.

Monitoring and reporting of outcomes

- > The chief applicant and associated LHN(s) must have processes in place to support the monitoring of newly implemented health technologies and the collection of relevant service, clinical and patient-related outcome data.
- > The chief applicant and associated LHN(s) must report adverse outcomes or incidents involving health technologies in accordance with the [Clinical Incident Management Policy](#).

8. Definitions

- > **Chief applicant:** Refers to the lead clinician who submits the SAPACT application form for new health technology.
- > **Health technology assessment (HTA):** Refers to the systematic evaluation of properties, effects, and/or impacts of health technology. It is a multidisciplinary process to evaluate the clinical, safety cost, economic social, organisational, and ethical issues of a health intervention or health technology (definition provided by the World Health Organisation).
- > **Health technologies:** For the purpose of this policy, health technologies are registered on the Therapeutic Goods Administration Australian Register of Therapeutic Goods (TGA ARTG), comprising of diagnostic and treatment interventions such as diagnostic tests, prostheses, implantable devices, and medical and surgical procedures.

Out-of-scope health technologies include those undergoing clinical, research or ethical trials, as well as those already assessed through other pathways within SA Health such as high-cost medicines, highly specialised therapies, biomedical engineering, pathology, radiology, and blood and tissue products. High-volume, low-cost health technologies are generally exempt from SAPACT assessment and are currently encompassed in other procurement and assessment processes.

- > **High-cost health technology:** Health technology in which the predicted expenditure is (a) $\geq \$100,000$ for a LHN per year or (b) $\geq \$300,000$ within the South Australian Public Health System per year.
- > **High-risk health technology:** Health technology in which TGA classifies as a class III high-risk medical device, regardless of anticipated expenditure associated with use.
- > **New and emerging health technology:** Health technology that demonstrates a certain degree of novelty and innovation, going beyond a simple iteration or upgrade in form and/or function from its predecessor (if one exists). The technology may be entirely new to SA Health or starting to gain some traction for use in one or more LHNs. Additionally, existing health technologies applied to new or expanded clinical indications may also be classified as new and emerging health technologies.
- > **SAPACT:** SAPACT is the statewide multi-disciplinary expert advisory committee of the South Australian Department for Health and Wellbeing, providing statewide governance, policy advice and evidence-based evaluation regarding the safety, clinically- and cost-effective use of new and emerging health technologies across SA Health.
- > **Statewide service planning implications:** Health technology in which its use and implementation will potentially involve two or more LHNs across SA Health.
- > **Statewide services:** means Statewide Clinical Support Services, Prison Health, SA Dental Service, BreastScreen SA and any other state-wide services that fall under the governance of the Local Health Networks.

9. Compliance

This policy is binding on those to whom it applies or relates. Implementation at a local level may be subject to audit/assessment. The Domain Custodian must work towards the establishment of systems which demonstrate compliance with this policy, in accordance with the requirements of the [Risk Management, Integrated Compliance and Internal Audit Policy](#).

Any instance of non-compliance with this policy must be reported to the Domain Custodian for the Clinical Governance, Safety and Quality Policy Domain and the Domain Custodian for the Risk, Compliance and Audit Policy Domain.
